Please refer to your application No.2943 dated 31/08/2018 filed online on the RTI web portal of DoPT on the subject cited. The same was received by the CPIO on 10/09/2018. In this regard, information is as under:

As per instruction/guidelines issued by the Ministry of Law & justice vide its letter No. G. 27031(11)/77-B & A, dated 26.10.1979 (copy enclosed), entire expenditure on actual conduct of elections to Lok Sabha is to be borne by the Government of India and such expenditure on conduct of election to State Legislatures, by the respective State Governments, when such elections are held independently. Further, in case these elections are held simultaneously, the expenditure is borne by the concerned State Government and the Central Government on 50:50 basis. The Commission bears only expenditure on honorarium to observers deployed during elections.

Information sought by the applicant is not available in the Commission. However, Commission has obtained figures regarding expenditure incurred for conduct of Lok Sabha general election which is re below:

General Election to Lok Sabha, 1977-Apportionment of expenditure incurred on purchase of election material between the Central and the State Governments.

Sir.

August, 1973, on the above subject and to say that the entire expenditure on actual conduct of elections to Lok Sabha is to be borne by the Government of India and such expenditure on conduct of election to State Legislatures by the respective State Governments, when such elections are held independently. The expression expenditure on actual conduct of election will cover items of expenditure on

- (i) Setting up of polling stations and making necessary arrangements at polling booths/counting centres.
- (ii) Payment of T.A/D A etc., to polling personnel/counting staff,
- (iii) Making transport arrangements for carrying polling and counting staff to the polling and counting centres and for the movement of election material and ballot boxes.
- (iv) Making temporary telephone facilities and electrical fittings etc to the polling booths/counting centres.
- (v) Purchase of election material like indelible ink. Ammonia paper etc. which are exclusively utilized for that particular election and
- (vi) Miscellaneous expenditure for the purpose of smooth conduct of polling and counting.

Expenditure incurred on items of common concern to the Central and State Governments, like expenditure on the regular election establishment, preparation and revision of electoral rolls, purchase of sieel/ballot boxes, is to be shared on 50:50 basis irrespective of whether such expenditure is incurred in connection with the elections to Lok Sabha or State Legislatures. In this connection your attention is invited to our letter no F. 2/51-C, dated the 13th June. 1951 and no. 2 (7)/52-C dated 1st August, 1952 (copy enclosed) which would show that expenditure on almirahs, steel boxes, steel racks etc. which are required for storage and preservation of electoral rolls, ballot papers, and other records of election will be shared between the Centre and the State on 50:50 basis. It will, therefore, not be correct to debit the entire expenditure on the purchase of election material of common concern to the Central and State. Governments to the accounts of Central Government merely because they were purchased during the Lok Sabha Elections, 1977, which were hold independently of the elections to the State Legislative Assembly.

In these circumstances, the Government of India regrets the inability to accept the State Governments proposal. The expenditure under consideration is accordingly to be included in the divisible pool of election expenditure.

- 1 Constructions of buildings, garages and godowns
- 2. Purchase/replacement of Staff, Car. Photocopier Machines and Duplicating Machines and Computer etc, without specific approval of the Govl. of India
- 3 Hiring of Aircraft/Ship or Helecopter without specific approval of Government
